## Payment of Registration Fees

### How to pay

The registration/application processing fee is payable in Euros only. Payment of fees should be made at a financial institution.

In order to conclude the registration/application process, Participants and Speakers **will be required to send a copy** of the payment of the registration fee (and the required documents: copy of your Student ID for the academic year 2011/2012, if applicable) by e-mail ([evc12@quintinoaires.pt](mailto:evc12@quintinoaires.pt)) or Fax (+351 218 217 397) and quote name, institution and country. Your registration/application will not be considered valid until the bank transaction receipt is successfully sent. ## Paying by NIB from a bank in PORTUGAL

## Paying by IBAN from a bank within the EU

Ask your bank to send the payment by IBAN (within EU only) quoting the following details:

It is essential that you **quote your reference**, to ensure that your funds are identified at our account as quickly as possible. It is recommended that you quote the IBAN in the account number field of the payment order, please ensure you opt to pay our receiving fees.

## Paying by SWIFT/BIC from a bank outside the EU

Ask your bank to send the payment by SWIFT (sometimes BIC) quoting the following details:

When making international bank transfers, please ensure you opt to pay our receiving fees and that you quote the SWIFT code and your reference, to ensure that your funds are identified at our account as quickly as possible.

**Registration will not be effective until:**

(a) Receipt of the Bank slip for Bank Transfer

After payment of registration/application fees an informal e-mail to the Congress Organizing Committee at [evc12@quintinoaires.pt](mailto:evc12@quintinoaires.pt) (or Fax +351 218 217 397) must be sent with a copy of the bank transaction receipt.

(i) To enroll as a student provide a copy of your Student ID for the academic year 2011/2012

(ii) Quote if you will be submitting a proposal

(b) All payments must be "free of any charges for the payee", i.e. all bank charges have to be borne by the sender.

To request the duly receipt of payment for your application/registration fee, Participants and Speakers will be required to send to the Congress Organizing Committee by mail ([evc12@quintinoaires.pt](mailto:evc12@quintinoaires.pt)) or Fax (+351 218 217 397) the name and the tax identification number NIF/CPF/NI/SSN.

**Normal registration expiry date** (i.e. fees have been paid and a bank transaction receipt is successfully sent):  
**April 30<sup>th</sup>, 2012**

**Late registration expiry date** (i.e. fees have been paid and a bank transaction receipt is successfully sent):  
**June 14<sup>th</sup>, 2012**

**Submission of proposals:** January 31<sup>st</sup>, 2012

**Notification of acceptance:** April 1<sup>st</sup>, 2012
